## **Process for Submitting Your Nominees**

Your explanation cannot exceed 400 words. Your explanation should include but not limited to the following:

- Describe her leadership, participation and contributions to her category of profession/career in which she is being nominated.
- Describe her leadership, participation and contributions in the community-at-large or volunteer activities.
- Describe her personal achievements (recognition by employers, peers and community or achievement of personal goals)

The deadline to submit your choice of a nominee is June 1, 2014. Nominees can not be a previous Honoree and/or featured in the past issues (Fall/October issue) of the EWOC special edition of THE HUB Magazine in the last 7 years. Selected nominees will receive an e-mail and telephone notification that they are a successful candidate for recognition of a 2013 EWOC Honoree. This communication will be completed by July 1, 2014.

## **Exceptional Women of Color (EWOC) Excellence Awards: Summary of Categories**

#### Arts and Culture

Women who make a significant, professional contribution to the development, preservation or appreciation of the visual or performing arts, which enrich the cultural life of the community.

## **Social Welfare & Community Activism**

Women who are advocates and committed to the improvement of the social/economic issues impacting the community especially women of color in transition.

### **Politics & Government Relations**

Women demonstrating distinguished leadership and commitment to programs improving legislative system/processes

#### **Communications and Public Affairs**

Women who make a significant, professional impact through public affairs, advertising, creative writing, public relations, communication technology or the media.

#### **Education and Research**

Women who excel in the field of education at any level, or women whose research has advanced a cause or bettered society.

#### Entrepreneur/Innovator

Women whose outstanding achievement and/or innovation in entrepreneurial or technological endeavors has led to successful business operations and/or success in breaking into new markets or technological fields.

## **Exceptional Career Mom**

Women who have committed their lives to the development and progress of their children as well as neighboring children while also devoting time to volunteer activities at school, in church, and/or participating in helping to build safe environments and communities for the families.

#### Health, Sport & Wellness

Women exemplifying excellence in the health profession, or women who make a significant contribution to improving the community in the areas of: mental, emotional or physical health; sport; athletics; recreation or fitness.

# **Management and the Professions**

Women who demonstrate outstanding achievement in: management in corporate, public sector or not-for-profit organizations and/or in the advancement of her/their profession.

## Young Women of Distinction

Women who demonstrate outstanding achievement in: improving the lives and inspiring activism of their peers, young women and girls in their communities (must be between the ages of 17-25 years of age).

### **Presidential Excellence**

Exceptional leadership commitment in her career and creating life changing experiences on a local to regional level.
